

ELECTIONS 2019 - NOMINATION FORM

FINAL DATE FOR RECEIVING NOMINATIONS: Sunday 19th May 2019, 3:00pm

Nominations may be made only on this form. It must be signed and returned to the Administrator at the Synagogue Office no later than Sunday 19th May 2019 at 3pm. If you require an additional form, please contact the Shul office or download one from the website.

All nominations received after this date or containing a greater number of names than there are respective positions to fill will be deemed invalid.

PLEASE NOTE: No person shall be deemed to be nominated unless nominated by at least **THREE ELECTORS**. 'ELECTORS' means a member who, at the time, is, in every respect, qualified to vote. A candidate may not stand for more than one local Honorary Officer (Executive) position but may stand for an Honorary Officer position as well as a Council position.

Also, under the Byelaws, every candidate must have signed at least one of their three nomination forms in the space beside their address. By doing so the candidate "agrees to stand for election to the office for which (s)he has been nominated and to act in accordance with and adhere to the Statutes and Regulations of the United Synagogue and the Byelaws for member Synagogues".
